

5.A DESCRIPTION OF SKILLS AND COMPETENCES ACQUIRED DURING THE EUROPASS MOBILITY EXPERIENCE (No.) Activities/tasks carried out (29a)(*) Participants will join in hands-on workshops, interactive sessions, collaborative group work and reflective journaling. This methodology should enable them to use ICT in class and to exploit and create ICT resources for teaching and learning. Participants will also join in sessions to analyse ways in which Information and Communication Technology can redefine the concept of critical literacy in class and its implications for students' learning. European Dimension in Education, networking and partnership building, planning of and discussion about dissemination strategies will help to share views and learning. Field projects and visits to places of historical and cultural significance will help participants to use contexts for creating learning content. Inquiry-based reflective practice and sharing of professional knowledge.
